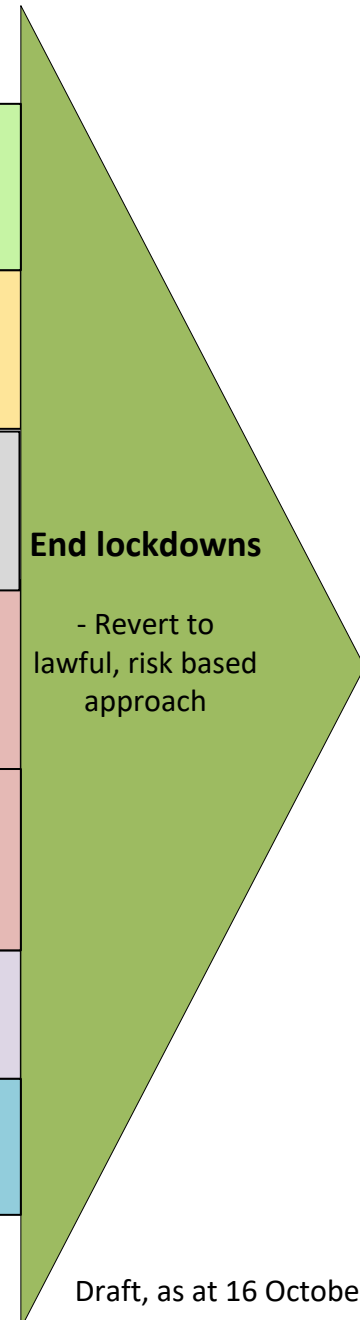


LIBERATE VICTORIA STRATEGY – STAGE 1

ACTIVELY SEEK INFORMATION AND PROOFS	<ul style="list-style-type: none"> - Issue FOI requests to departments for briefs to Ministers any other proofs of pandemic measures - Send MPs questions to ask in Parliament, to also obtain information and proofs. - Brief journalists.
DE-ESCALATE THE HYSTERIA	<ul style="list-style-type: none"> - Educate the community (e.g. share this website, issue short pamphlets) - Advertise key messages to target audience via social media (Facebook/Twitter etc.) - Educate public representatives and journalists (educate via articles, books)
COMPLAINTS AGAINST PUBLIC SERVANTS ACTING ILLEGALLY	<ul style="list-style-type: none"> - Complain to AHPRA against Victoria’s CHO and other medical practitioners who are in breach of Victoria’s laws and international covenants - Letters to Secretaries of DPC, DTF, DHHS to apprise them of their support for illegal acts.
LEGAL CHALLENGE	<ul style="list-style-type: none"> - <i>Habeas corpus</i>, legal challenges in Victoria’s Supreme Court against lockdowns, mandatory mask orders, etc. - In the High Court of Australia against lockdowns? - Complaint about crimes against humanity to the International Criminal Court
LEGAL – CASES LODGED FOR COMPENSATION	<ul style="list-style-type: none"> - Compensation cases by workplaces across Victoria for loss suffered during the lockdowns - Compensation cases by those who were brutalised by the police - Case to nullify any finances issued during this period
ADVOCACY	<ul style="list-style-type: none"> - Advertisements in newspapers by business, lobbying, - change.org and parliamentary petitions
EVENTS AS NECESSARY	<ul style="list-style-type: none"> - Share information regarding mental health for those suffering from the lockdowns - Organise - e.g. possibly stay-at-home protests, potentially large scale civil disobedience



LIBERATE VICTORIA STRATEGY – STAGE 2

At this stage the focus is purely on Stage 1

REGAINING TRUST IN OUR INSTITUTIONS & WITH EACH OTHER	<p><i>This episode has trust in our institutions – e.g. Police, elected representatives, the bureaucracy. And has divided Victorians – e.g. regional vs. Melbourne.</i></p> <p>Healing this is a priority. Will require community leadership.</p>	Learn lessons from this episode and embed necessary change
ROYAL COMMISSION	<p>A Royal Commission must be established (as soon as possible) to review:</p> <ul style="list-style-type: none">- why Victoria's laws have been disobeyed; and- how such an episode can be prevented from happening again	
ENSURE NECESSARY CHANGES	<p><i>Do not let go till everything that needs to change is changed, e.g.</i></p> <ul style="list-style-type: none">- the Constitution of Victoria to prevent emergency powers- all relevant laws (e.g. abolishing the precautionary principle)- all relevant institutions (e.g. Police, public service)
